## Terms and Conditions of Sale

1. The following terms apply to the sale of goods specified on the reverse side of this order (the "Goods") by Electrolux Home Products Pty Ltd ("EHP") to the Customer.
2. The price payable for the purchase of the Goods is specified on the front of this order. Unless otherwise agreed in writing all Goods will be supplied on a payment before delivery basis. This is a made-to-order product with up to eight weeks for delivery from order acceptance date.
3. Any order from the Customer for the supply of Goods shall not be binding on EHP until accepted by EHP.
4. No variation or modification or substitution of these Conditions of Sale shall be binding on EHP unless specifically accepted by EHP in writing.
5. Unless agreed in writing EHP shall arrange delivery of the Goods to the Customer's nominated delivery point at their premises or to the front door of the Customer's premises if any lifting equipment (for example a crane) is required to position the Goods on the Customer's premises ("Delivery"). Delivery does not include connection of the Goods to a gas supply.
6. EHP is not liable for any claims for non-fulfilment or late Delivery of Goods or for any loss or damage (including consequential loss or damage) suffered by the Customer arising from the delay in Delivery or failure to deliver or occurring after delivery. The Customer shall accept and pay for the Goods notwithstanding late Delivery.
7. The Customer shall upon placing its order advise EHP of the nominated delivery point.
8. Electrolux Top Service for Delivery of Goods within Sydney, Melbourne or Brisbane metropolitan areas is included in the price. An additional delivery cost will be incurred by the Customer for Delivery outside these areas.
9. Any additional delivery service required e.g. crane delivery, must be organised by the Customer at their expense.
10. EHP staff will contact the Customer to confirm the delivery date.
11. Without prejudice to any other rights EHP may have against the Customer and to the extent permitted by law, the Customer shall indemnify EHP for and save it harmless from, any loss, damage or expense incurred by the Customer should the Customer cancel any order or breach these Terms and Conditions of Sale.
12. Whilst risk in the Goods shall pass on Delivery, legal and equitable title shall remain with EHP until payment in full for the goods is made to EHP.
